The BAT chorus sang several songs with updated words by Becca Ritchie making the point about testing & the reasons to Opt Out. Julianna Dauble was our charming emcee, welcoming some terrific speakers. We heard from parents about their decision to Opt their children Out and Elizabeth Hanson spoke about the money ties to corporate reform and Pearson's fingers in all the testing pies, talking about the increased number

of people unable to pass the GED since being rewritten by Pearson. Elizabeth Scott spoke powerfully about the reason behind a lot of the reform and testing...DATA MINING! An emotional moment was when a VERY LONG scroll was unwound with names on it representing the 7,000 students who did not graduate in 2012 due to failing one or more standardized test in Washington State. Graduation gowns and people laying on the ground represented the loss of those students dreams. Susan DuFrense choreographed this event.

We heard from some impassioned Tyee High School students who are right now fighting to graduate while being unable to pass those tests. Can you imagine doing all you are supposed to do to graduate and one test holds you back? There are many reasons to Refuse the Tests but this is surely one of the best! Poli-Sparks

Teachers from around the state gathered in Olympia for the annual PoliSPARKS training led by Rainier Staff Elizabeth Beck, Tacoma Staff Jessica Upton and Rainier WEA PAC Chair Julianna Dauble. Attendees shared their current concerns with education and spoke of the hope they see in political spheres before learning a bit about the history of the labor movement. There were breakout sessions with WEA's lead lobbyist, Lucinda Young, election/campaign highlights and communication updates from other WEA staff. Members then practiced lobbying each other on key issues such as testing, evaluation, and class size. That evening, dinner was a meeting with Speaker of the House Frank Chopp, Representatives Steve Bergquist and Carol Gregory and Senators Marko Liias and Bob Hasegawa. Members came away from that conversation inspired by lawmakers

who truly endeavor to authentically support our schools. Monday everyone competed in 'The Amazing Race' and explored the capitol buildings with fun tasks before meeting Superintendent Randy Dorn at OSPI for lunch. The meeting was insightful and at times rather tense as teachers shared frustrations with our elected school chief. Finally, PoliSPARKERS headed back to the capitol offices for personal appointments with legislators. The lobby skills they practiced were put to immediate use and WEA now has another set of highly motivated and skilled members ready to take on the challenges Olympia will continue to present.

Re-Authorization of ESEA

The 114th United States Congress has taken up the work that is 13 years overdue.

The Elementary and Secondary Education Act was passed and signed into law in 1965 by President Johnson. It was renamed in 2001 when President H. W. Bush signed No Child Left Behind into law. In 2007 a commission was formed to study the effects of NCLB. The controversies that surround this work has limited the progress.

In 2015, former Secretary of Education and current Senator from Tennessee, Lamar Alexander, Jr. is chairing the Health, Education, Labor and Pensions committee in the US Senate. He has vowed to move the reauthorization of ESEA.

NEA has been involved in the re-write of this law and has given valuable perspective to those working on it. Join their voices to tell our senators that the over testing is not working. Teachers need time to teach and students need time to learn. Grade-band assessment (eg. grades 4th, 7th and 10th) will inform schools of progress but will still allow for this much needed time. Educators need a dashboard of indicators that shows student growth.

WEA Representative Assembly in April

April 23-25 your elected representatives will gather in Bellevue to hold this years Representative Assembly, often called RA.

They will debate suggested resolutions (our guiding beliefs) and New Business Items, also known as NBIs (one year actionable items for WEA). Decisions made at RA guide the direction of the organization.

Awards are given out at the RA, as well as dignitaries from around the state come to speak to the body. Saturday will begin with an early bus ride to Olympia for a rally on the steps. You do not have to be a representative to join the rally. It will start at 9:30 AM.

This year the RA will also be electing our NEA board directors for Washington state. There is one position open. These directors join directors from other states to help guide NEA policy and participate in lobbying in Washington DC.

The Washington Education Associa-

tion's president, Kim Mead, presides over this annual meeting.
